**\*\*CLEAN UP DEPOSIT\*\*** A (\$50.00) CLEAN UP DEPOSIT WILL BE REFUNDED WITHIN 7 DAYS AFTER INSPECTION AND APPROVAL FROM THE EVENT MONITOR. LESSEE MUST MAKE ARRANGEMENTS AND PICK UP THE (\$50.00) REFUND CHECK FROM THE YACHT CLUB.

**\*\*AGE RESTRICTION\*\*** 25 AND OVER.

**\*\*CAPACITY WITH DANCE FLOOR IS (150) PEOPLE.**

**\*\*CAPACITY WITHOUT DANCE FLOOR IS (200) PEOPLE.**

INTERCITY YACHT CLUB IS A SMOKE FREE AND DRUG FREE FACILITY, ANY USE IS CAUSE FOR IMMEDIATE TERMINATION OF THE EVENT.

INTERCITY YACHT CLUB OR ITS MANAGEMENT RESERVES THE RIGHT UNDER CURCUMSTANCE OF DISTURBANCE OR MISCONDUCT DURING THE EVENT, TO TERMINATE THIS AGREEMENT WITHOUT NOTICE.

I/WE THE UNDERSIGNED AGREE THAT THE LESSEE SHALL BE RESPONSIBLE FOR THE REMOVAL OF ALL RUBBISH, FROM TABLES AND THE BUILDING AFTER THE EVENT AND PLACE THAT RUBBISH IN THE RUBBISH BIN OUTSIDE OF THE BUILDING.

ALL RENTALS WILL END 30 MINUTES BEFORE THE CONTRACT TIME. LESSEE MAY SET UP HALL (1) HOUR BEFORE THE CONTRACT STARTING TIME. THE LESSEE HAS (1) HOUR AFTER THE CONTRACT CLOSING TIME TO CLEAN UP ALL USED AREAS OR THE DEPOSIT BE FORFEITED.

THE LESSEE AGREES TO BE FULLY RESPONSIBLE FOR AND INDEMNIFY, DEFEND AND HOLD HARMLESS INTERCITY YACHT CLUB, ITS OPERATORS, CONTRACTORS, OFFICERS AND AGENTS, FOR ALL DAMAGES ORIGINATING FROM OR IN CONNECTION WITH, ALL ACTIVITIES OF CUSTOMERS GUESTS AND ATTENDEES AND ALL CLAIMS OR DEMANDS FOR DAMAGES TO PROPERTY OR FOR INJURY TO OR DEATH OF PERSONS DIRECTLY RESULTING FROM SUCH ACTIVITIES OF WHATSOEVER NATURE (EXCEPT LOSS OR DAMAGES TO CAUSED BY THE GROSS NEGLIGENCE OR WRONGFUL ACTS OF INTERCITY YACHT CLUBS CONTRACTORS OR OFFICERS)

THE LESSEE MUST GIVE THE LESSOR (7) BUSINESS DAYS OF NOTICE OF CANCELLATION OR FORFIET THE TOTAL DEPOSIT. IF PROPER NOTIFICATION IS GIVEN ONLY \$300. OF THE TOTAL DEPOSIT WILL BE RETURNED. NOTIFICATION MUST BE IN WRITING.

THE LESSEE AGREES NOT TO SELL TICKETS FOR ADMISSION, NOR SELL ACCOHOIC BEVERAGES ON THE PREMISSES UNDER TERMS OF THIS CONTRACT.

A MAXIMUM HALL CAPACITY IS 200 PEOPLE. THE LESSEE AGREES THAT WHEN THE MAXIMUM CAPACITY IS REACHED NO OTHER GUESTS WILL BE ALLOWED IN.

THE LESSOR RESERVES THE RIGHT TO PRECLUDE ANY DATES FROM THE CALENDER FOR INTERCITY YACHT CLUB FUNCTIONS.

ALL RENTERS OF THIS FACILITY MUST BE AT LEAST 25 YEARS OF AGE AND HAVE A VALID I.D.
